MEMBERSHIP AGREEMENT

In consideration of an annual membership fee of \$350, payment of which is hereby acknowledged, and the mutual agreements and covenants hereafter set forth, the parties hereto agree as follows:

1. Family Resources, through its purchasing department, will negotiate volume buying discounts with various suppliers of commodities routinely purchased by operating non profit agencies and organizations, which discounts will be available to members who choose to purchase said items through the 'program'.
2. Family Resources will provide each member with a Network Supplier List with contact information for each participating supplier together with a supplier catalogue or available item list and/or on line ordering instructions when available.
3. Family Resources will supply each member with an individual identifier and instructions with regard to how to use the identifier to order eligible supplies from any or each participating supplier and receive the negotiated volume discount price.
4. Members will be eligible to receive supplemental consulting or negotiating services for individual contracts for an additional, agreed upon fee.
5. Member agrees to and understands the following conditions of participation:
 - A. Member understands and agrees that the identifier provided is exclusive to the member and will use the identifier only for orders of supplies for its use and will not allow the identifier to be used to obtain supplies for personal use of any individual or for the use of any other organization or agency.
 - B. Member understands that participation is limited to access to negotiated bulk purchase prices only and that Family Resources and the network makes no representation concerning description or quality of goods purchased and that all transactions made through the network are in all respects the sole responsibility of the vendor/supplier and the purchasing member.
 - C. Member understands that negotiated prices and conditions of sale are subject to change by the manufacturer, vendor/supplier and are not guaranteed for any period of time.
 - D. Membership is for the fiscal year of enrollment only and must be renewed by re enrollment each fiscal year for participation.
 - E. Member understands that additional or supplemental consulting or negotiating services may be available on a quoted fee basis after member has provided Family Resources with sufficient, accurate, information as may be reasonably required to evaluate the proposed or potential project.
 - F. Member understands that additional or supplemental consulting or negotiating services may be made available on a quoted fee basis after member has provided Family Resources with sufficient, accurate, information as may be reasonably required to evaluate the proposed or potential project.
 - G. Membership privileges may be withdrawn should member fail to timely pay any vendor/supplier for goods purchased through the network or provide inaccurate information to the network for the purpose of obtaining an advantage.
 - H. Member agrees that all purchases of eligible materials from participating vendors/suppliers will be made through the network according to the established protocol.

The term of this agreement shall commence on the date of its execution and end on the 30th day of June, 2016.
